Content: "Expected Outcome" and main "Areas of Benchmarking"

- "institutional framework" of IGR in politics and law, i.e. cooperation, participation, competition, between Federation and Cantons, top down and bottom up
- "accountability" (democracy) in a multilevel system
- "knowledge on the role and status of the judicial organ in IGRs", i.e. control of the constitutionality: role of the courts and of politics (compared with the House of Federations)
- "institutional mechanism for managing and coordinating the overall IGRs" or "The mechanism by which the overall system of IGR is managed and coordinated"", a Swiss example could the adaption of the "NFA", i.e. the process of periodical adaption of the distribution of tasks and financial equalization
