Contributing to the Global Agenda addresses some of the most crucial and innovative issues on the global agenda of the 21st century, those which must be fully taken on board and implemented in order to move towards a better world.

Over a period of five months, the Forum Dialogues have sought to unite the efforts of various agents such as international institutions, the United Nations system, NGOs, foundations, academia, think tanks, cultural associations, networks, companies and trade unions.

This Dialogue is an example of cooperation between different agents with different visions and interests, as its Program Committee includes representatives of various organizations of international renown such as Club de Madrid, the Asian Heritage Foundation, the Asociación Española de Ciencia Política y de la Administración (AECPA, Spanish Association of Political Science and Administration), the Centre de Treball i Documentació (CTD, Catalan Labor and Documentation Center), the Instituto de Ciencias Políticas y Sociales (ICPS, Institute of Political and Social Sciences), the Institut d'Estudis Autonòmics (Institute of Autonomous Studies), the Forum of Federations, the Fundació Alfons Comín, the Fundació

The Dialogue revolves around a shared space in which these key players have organized various sessions, round tables and debates that will be general and global in their approach and which seek to complement the diversity of themes that the Forum has been addressing in its various Dialogues that belong to the Global Agenda for this century.

This closing Dialogue has a multifaceted structure as it enables participants to follow several different tracks, either in parallel or consecutively; they will thus be able to choose the issues of most interest or concern to them.

These tracks will conclude with a plenary session on the morning of September 26 in which the various panels will present their conclusions, and at the end of this conference a special closing session of the Dialogues will be held.

The Dialogue Contributing to the Global Agenda addresses three basic questions:

- •What are the challenges that humankind must face at the beginning of the 21st century?
- •Who are the key players who have to cope with them and what is the growing role of civil society?
- •What new values, attitudes and behaviors are required to achieve change?

What kind of future, what should be done, who should do it, and how should it be done: these are the questions that lie behind the reflections to be presented during the last week of the Universal Forum of Cultures.

The first block will mainly address issues such as the relationship between democracy and poverty, global social (dis)order and fair trade.

The second will develop a dialogue regarding the new agents of social change and the much awaited and necessary reform of the United Nations and the system of international institutions.

Finally, the third block will deal with issues such as implementing democracy while respecting and integrating diversity, the fight against corruption in a globalized world, and the importance of respecting biodiversity and intangible heritage.

All these dialogues will provide part of the new values, attitudes and actions which the Universal Forum of Cultures wishes to promote as a legacy for the international community and humanity itself.
